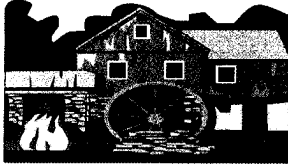

2009 RECREATION BADGES

The Board of Trustees of the Powder Mill Village Homeowners Association will again utilize a photo ID system to gain entrance to the pool and tennis courts. The regular 2008 ID and Guest badges will be carried over, so please do not dispose of them, they need '09 validation stickers to be valid for the 2009 pool season. If you have lost your '08 badges, you will have to pay the standard replacement fee, if you are a new Owner, there is no fee for new badges. ***Rental Unit Owners- you must sign & forward the application form to the Tenant residing in your unit. Remember, only 1 family per unit will be given badges, not both the Owner & Tenant.**

New & replacement photo identification badges and validation stickers for your 2009 photo ID badges will be issued on the following days in the clubhouse at 84 Continental Road:

Saturday May 9, 2009 & Sunday May 17, 2009

10:00 a.m. to 2:00 p.m.

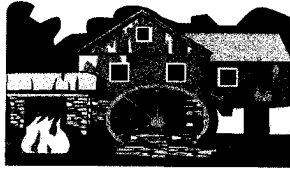
Enclosed please find your 2009 Pool/Tennis Pass Application Form which must be filled out and brought to the clubhouse where your badges will be produced or validated. If you cannot attend the above listed dates & need new badges, you may call Gina in the office at extension 15 to make an appointment to come in and have your pictures taken and badges produced in our office.

*** Please be advised, pool photo ID's & validation stickers will not be issued unless the application is fully completed and presented on picture day. Please be sure to complete the entire application form. IF YOU ARE A TENANT, THE OWNER OF YOUR UNIT MUST SIGN THE APPLICATION TO GET YOUR BADGES, NO EXCEPTIONS.**

There will be two validation stickers issued to each owner for their two (2) free guest passes. Each additional guest pass/sticker will cost \$15.00 with a maximum total of 5 guest passes per unit allowed. ***New 2009 rule: Any Owner residing alone in their unit is entitled to one extra free guest pass, for a total of three (3)-this does not change the maximum 5 allowed.**

Pool photo ID's will not be issued to any unit owner that is not in good standing with their maintenance fees. All past due amounts must be paid in full to receive pool photo ID's or have your ID validated. This would include any past due maintenance fees, late fees, fines, or penalties that are due on your unit.

All pool and tennis court use, as well as voting privileges shall be suspended until the unit is in good standing. The suspension of privileges will pertain to all family members, residents, guests and tenants of the affected unit, if applicable. **No persons shall be permitted in the pool or tennis court area without a valid 2009 pool photo ID badge.**

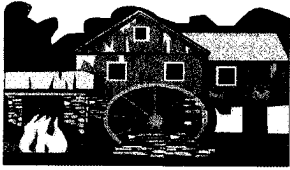

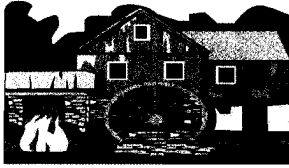
SWIMMING POOL RULES 2009 SEASON

THESE RULES WILL BE ENFORCED VIGOROUSLY

Please help us to keep the safety and health conditions in the pool at their maximum level by cooperating to your fullest...

1. ALL RESIDENT OWNERS WILL BE ISSUED RECREATION PASSES THROUGH THE ASSOCIATION MANAGEMENT OFFICE BASED UPON THE INFORMATION SUPPLIED FROM THE RECREATION PASS APPLICATION. YOU MUST SUPPLY THE NAMES AND AGES OF THE OCCUPANTS TO RECEIVE THE PASSES. NON-RESIDENT OWNERS WILL BE ISSUED PASSES FOR THE EXCLUSIVE USE OF THEIR TENANTS UPON THE SAME BASIS AS RESIDENT OWNERS. ALL PERSONS ENTERING THE POOL AREA MUST SIGN THE REGISTRY ON A DAILY BASIS.
2. VALID 2009 RECREATION PASSES MUST BE WORN BY MEMBERS AND GUESTS AT ALL TIMES AND SHOWN TO THE LIFEGUARD PRIOR TO ENTERING THE POOL.
3. LOST OR DAMAGED PASSES WILL BE REPLACED AT A CHARGE OF \$25.00 PER MEMBER PASS, \$15 FOR GUEST PASS.
4. GUESTS WILL BE PERMITTED TO ENTER THE POOL ONLY IF THEY POSSESS A VALID GUEST PASS. ALL GUESTS **MUST** BE ACCOMPANIED BY AN OWNER/RESIDENT AT ALL TIMES. ALL GUESTS ARE TO REGISTER UPON ENTRY TO THE POOL.
5. ANIMALS ARE NOT PERMITTED IN THE RECREATION AREA, INCLUDING THE PARKING LOT, TENNIS COURTS, POOL AND CLUBHOUSE.
6. POOL SEASON WILL RUN FROM MEMORIAL DAY WEEKEND THROUGH LABOR DAY WEEKEND.
7. THE POOL WILL BE OPEN FROM 10:00 A.M. UNTIL 8:00 P.M. WEEKENDS ONLY UNTIL SCHOOL CLOSES, THEN 10:00 A.M. TO 8:00 P.M. 7 DAYS A WEEK INCLUDING HOLIDAYS.
8. RESERVING OF CHAIRS OR TABLES IS PROHIBITED. ANY UNATTENDED TOWELS/BELONGINGS LEFT TO RESERVE A CHAIR OR TABLE WILL BE REMOVED BY THE LIFEGUARD. ALL BELONGINGS INCLUDING COOLERS CAN BE LEFT IN THE CLUBHOUSE. TABLES CANNOT BE MONOPOLIZED FOR LONGER THAN 30 MINUTES. THEY ARE TO BE SHARED BY ALL RESIDENTS FAIRLY.
9. THE POOL MAY NOT BE USED UNLESS A LIFEGUARD IS ON DUTY.
10. THE BATHHOUSE IS PROVIDED FOR THE CONVENIENCE OF SWIMMERS.
11. PARENTS ARE RESPONSIBLE FOR THE CONDUCT OF THEIR CHILDREN IN THE POOL COMPLEX.
12. AT LEAST ONE PARENT MUST BE PRESENT AT THE POOL WHILE THEIR CHILDREN UNDER 12 YEARS OF AGE ARE IN THE POOL AREA, UNLESS ANOTHER ADULT, WHO WILL BE PRESENT IN THE POOL, ADVISES THE LIFEGUARD THAT HE/SHE HAS ASSUMED THE RESPONSIBILITY FOR THE CHILD'S SAFETY AND BEHAVIOR.
13. NO RUNNING, ROUGH-HOUSING OR BALL PLAYING IS ALLOWED IN THE POOL AREA.
14. THE PRIMARY RESPONSIBILITY OF THE LIFEGUARD IS THE SAFETY OF THE SWIMMERS. HE/SHE HAS AUTHORITY TO ORDER ANY PERSON OUT OF THE POOL FOR ANY PORTION OF THE DAY THEY DEEM APPROPRIATE IF THE PERSON'S BEHAVIOR DETRACTS FROM THE SAFETY OF THE POOL FACILITIES BY OTHERS.
15. NO GLASS OR BREAKABLE CONTAINERS ARE PERMITTED IN THE POOL AREA.
16. UNLESS POTTY-TRAINED, ALL INFANTS MUST WEAR RUBBER PANTS OR SWIMMIES IN BOTH POOLS. NO DISPOSABLE DIAPERS ARE ALLOWED IN THE POOL.
17. NO RUBBER TUBES AND RAFTS, BALLS, FRIZBEES, WATER GUNS AND WATER RIFFLES ARE ALLOWED IN OR AROUND THE POOL COMPLEX. NO TOYS ARE ALLOWED IN THE POOL.
18. ANY PERSON SHOWING EVIDENCE OF SKIN DISEASE, SORES, INFLAMED EYES, COLDS, NASAL OR EAR DISCHARGES SHALL BE REFUSED ADMITTANCE.
19. ONLY BATHING SUITS ARE ALLOWED. (NO CUT-OFFS, GYM SHORTS OR T-SHIRTS.)
20. ABSOLUTELY NO DIVING.
21. ABSOLUTELY NO SMOKING ALLOWED AT THE POOL, CLUBHOUSE, TENNIS COURTS OR PLAYGROUND AREAS. SMOKING IS PERMITTED IN THE PARKING LOT ONLY.

TENNIS COURT RULES

1. DURING POOL HOURS, COURT TIMES MAY BE RESERVED WITH THE LIFEGUARD. TIMES MAY BE RESERVED FOR ONE HOUR ONLY AND MAY NOT BE DONE MORE THAN 3 DAYS IN ADVANCE. MEMBERS PLAYING ON AN UNSCHEDULED COURT WILL RELINQUISH THAT COURT TO A MEMBER WITH A SCHEDULED COURT TIME
2. FOOD IS NOT ALLOWED ON THE TENNIS COURTS.
3. NO ONE SHALL BE WITHIN THE TENNIS COURT ENCLOSURE UNLESS THEY ARE ACTUALLY PLAYING TENNIS. ABSOLUTELY NO RIDING OF BIKES, SKATEBOARDS, SKOOTERS, ROLLER SKATES/BLADES, ETC. IS ALLOWED.
4. VALID RECREATION PASSES MUST BE WORN AT ALL TIMES AND SHOWN TO THE LIFEGUARD UPON REQUEST.
5. ALL PLAYERS WILL BE EXPECTED TO CLEAN COURTS AFTER THEIR USE (TENNIS BALL CANS, DRINKS, ETC.).

CLUBHOUSE RULES

1. DURING THE SUMMER, THE CLUBHOUSE WILL REMAIN OPEN UNTIL 8:00 P.M. FOR ALL MEMBERS. NO PRIVATE OR SPECIAL USE WILL BE PERMITTED DURING THE POOL SEASON.
2. ALL MEMBERS HAVE EXCLUSIVE USE OF THE CLUBHOUSE AND KITCHEN FACILITIES FOR RECREATION PURPOSES, SUCH AS CARD PLAYING, ETC.
3. ANY AND ALL MEMBERS USING THE CLUBHOUSE WILL BE RESPONSIBLE FOR CLEAN UP, LIGHTS AND LOCK UP AFTER EACH USE OF THE FACILITIES.
4. FOR PRIVATE USE OF THE CLUBHOUSE BY MEMBERS A SECURITY DEPOSIT OF \$100.00 AND ADMINISTRATION FEE OF \$50.00 WILL BE REQUIRED. AFTER THE USE, IF NO DAMAGES HAVE OCCURRED AND THE CLUBHOUSE HAS BEEN RESTORED TO SATISFACTORY CONDITION, THE SECURITY DEPOSIT WILL BE RETURNED. PRIVATE CLUBHOUSE RENTALS ARE RESTRICTED WHILE POOL SEASON IS IN PROGRESS.
